Blue Sky Metals LLC will not sign an unconditional partial or final release of lien until payment has cleared our bank account. Blue Sky Metals LLC does not accept check images as proof of payment. Blue Sky Metals LLC will not be held liable to any party for the delay of a loan or sale closing due to the failure of funds clearing our bank account in a timely manner. Blue Sky Metals LLC requires a minimum of two working business days to complete and submit release of liens, and may require more time. Payment will be applied to the oldest outstanding invoice, and may not be allocated towards specific jobs and/or invoices except for at the sole discretion of Blue Sky Metals LLC.

LATE CHARGES: A late charge of 1.5% monthly (18% per annum) will be added to any balance that has not been paid by the due date. **LEGAL FEES:** Reasonable attorney fees, all cost of litigation, and collection costs incurred in collecting delinquent accounts, whether or not suit is filed, will be added to the account balance.
